# 國立中興大學中國文學系研究生獎助學金審核辦法

- 一、本辦法係依據「國立中興大學研究生獎助學金實施辦法」訂定之。
- 二、本系研究生獎助學金審核委員會,由本系系主任導師、研究生導師及本系學生事務委員會組成之。由系主任導師擔任召集人,委員會負責審核本系研究生獎助學金之申請及分配事宜,並得依實際狀況審定本辦法。
- 三、本系研究生獎助學金分為獎學金、助學金二種。獎學金係獎勵性質,作為優秀研究生獎學金之用。助學金係補助性質,申領者需協助本系所之教學相關事宜。
- 四、助學金申請以本系碩士班一至三年級、博士班一至五年級為原則,惟在職生不得申請。

### 五、獎學金頒發對象:

### (一)新生入學獎學金(二者擇一申請):

- 碩、博士班甄試入學正取第一名及一般考試入學正取第一名,且於 當學年度入學者,於第一學年(九月至翌年六月)每月頒發 6,000 元, 出缺不予遞補,全職生不得申請。
- 2. 本系應屆畢業生,經甄試入學考試進入本系碩士班研究所就讀者, 其在校學業成績總平均居全班前 20%(含),且於該學年度至本系 就讀者,於第一學年上下學期各頒發金額為本系碩士班學雜費基數

## 之獎學金。

- (二)本系研究生研究成果傑出者,本系另訂有「國立中興大學中文系研究生學術研究成果獎勵辦法」,經審核後核發。
- 六、本辦法如有未盡事宜,依本校研究生獎助學金實施辦法辦理。
- 七、本辦法經系務會議通過並依行政程序呈請校長核可後實施,修正時亦同。

# National Chung Hsing University Department of Chinese Literature Regulations for the Review of Graduate Scholarships and Financial Aid

- Article 1 These regulations are established by NCHU "Regulations for the Administration of Graduate Student Scholarship and Student Aid of National Chung Hsing University."
- Article 2 The Departmental Graduate Scholarship and Financial Aid Review Committee comprises the Department Chair Advisor, Graduate Advisors, and the Departmental Student Affairs Committee. The Department Chair Advisor serves as the convener. The committee reviews applications and allocates scholarships and financial aid for the department's graduate students. It may also revise these regulations as deemed necessary based on actual circumstances.
- Article 3 The departmental graduate scholarships and financial aid are divided into two categories: scholarships and financial aid. Scholarships are merit-based and awarded to outstanding graduate students. Financial aid is need-

based, and recipients are required to assist with teaching-related tasks within the department.

Article 4 Applications for financial aid are generally limited to first to third-year master's students and first to fifth-year doctoral students in the department. However, part-time students are not eligible to apply.

### **Article 5** Recipients of the Scholarship:

- 1. Scholarships for Incoming Students (Choose one to apply):
  - (1) Master's and doctoral students who are admitted as the top-ranked candidates through either the admission by recommendation or the general entrance exam and enroll in the same academic year will receive a scholarship of NT\$6,000 per month during the first academic year (from September to June of the following year). Vacancies will not be filled. Part-time students are not eligible to apply.
  - (2) Graduates of this department who are admitted to the master's program through admission by recommendation and whose overall academic performance ranks within the top 20% of their class (inclusive) during their undergraduate studies and who enroll in the same academic year will be awarded a scholarship equivalent to the tuition and fees of the master's program in this department for each semester of the first academic year.
- 2. Outstanding academic research achievements of graduate students in this department are recognized according to the "Regulations for Academic Research Achievement Awards for Graduate Students of

the Department of Chinese Literature, National Chung Hsing University," and will be awarded after review.

- Article 6 Any matters not covered by these regulations shall be governed by the university's "Regulations for the Administration of Graduate Student Scholarship and Student Aid."
- Article 7 These regulations shall be implemented after being approved by the Department Affairs Meeting and submitted for the President's approval following administrative procedures. The same process applies when making amendments.
